

# WEDDING PHOTOGRAPHY AGREEMENT

This Wedding Photography Agreement ("Agreement") is made and entered into in Salt Lake City, Utah, as of May 1, 2011, by and between Eleora, LLC, a Utah Limited Liability Company, of 1400 S. Ambassador Way West, Salt Lake City, Utah, 84108, doing business as Eleora Photography ("Eleora"), and the undersigned (collectively, the "Bride and Groom").

The Bride and Groom desire to retain Eleora, and Eleora desires to be retained, to photograph the Bride and Groom's wedding ceremony, reception, and any other activities as mutually agreed upon, on July 10, 2011 between 4:00 PM and 11:00 PM (the "Wedding").

**SCOPE OF WORK** Eleora will provide photography services for the Bride and Groom, described as follows: (a) photographs of the pre-wedding ceremony preparation activities, (b) photographs of the wedding ceremony, (c) portrait photographs of the Bride and Groom alone and with the wedding party and/or anyone else desired by the Bride and Groom, and (d) photographs of the wedding reception. All photographs generated from such services will be collectively referred to as the "Photographs". The Bride and Groom hereby retain Eleora as the sole and exclusive provider of photography services for the Wedding.

**PHOTOGRAPHS** Within sixty (60) days of the Wedding, Eleora will set an appointment with the Bride and Groom to review "Selected Photographs" (i.e., those photographs which have been selected and edited by Eleora), and to discuss the Products (e.g. prints, albums) available to the Bride and Groom for purchase. Eleora will promptly thereafter make the Selected Photographs available in a private gallery in its online store, and will provide the Bride and Groom access to this private gallery. The Bride and Groom may then purchase Products from Eleora's online store, and may also permit others (e.g. family, friends) to access the private gallery and purchase Products.

**COPYRIGHTS** Eleora will retain full title, rights, ownership, and copyrights to all Photographs. The Bride and Groom understand that no Photograph, nor any derivative of any Photograph, may be produced or reproduced by anyone but Eleora, without the written consent of Eleora.

**COMPENSATION** The Bride and Groom will pay Eleora: (a) \$60 per hour for all services performed at the Wedding, plus any reasonable food, lodging, and travel expenses incurred, all within thirty (30) days of the Wedding, and (b) a non-refundable deposit of \$300, which deposit will be credited toward the Bride and Groom's final bill.

**CANCELLATION** This Agreement may be cancelled by either party at any time that is at least fourteen (14) days before the Wedding. Cancellation must be made via written notice.

**GENERAL PROVISIONS** This Agreement constitutes the entire agreement between the parties on the subject matter herein. This Agreement supersedes all prior understandings, agreements, and documentation relating to such subject matter. Amendments are permissible, provided such Amendments are in writing and signed by both parties. The terms of this Agreement are severable. The laws of the State of Utah will govern this Agreement. Any litigation or arbitration regarding this Agreement will be brought exclusively in Salt Lake City, Utah. Interest will accrue at a rate of one and one half (1.5) percent per month on any amount not paid by its due date. In any action to enforce the terms of this Agreement, the prevailing party will be entitled to its attorney's fees. The Bride and Groom are jointly and severally liable hereunder.
